The members of the Art Alliance of Central Pennsylvania are excited to present their 50th Anniversary Juried Exhibition in the HUB Robeson Gallery at Penn State. The show will highlight the inspiring work of artists in the Central Region and beyond. We invite you to join other talented artists by submitting images of your work for consideration by our juror.

ELIGIBLE WORK

Two- and three-dimensional works that have not received awards in Art Alliance shows are eligible. All work must be original; reproduction prints are not acceptable.

- 2D work may not exceed 72 inches in width and 84 inches in height, including frame.
- All work must be securely wired and ready to hang. **Poorly framed work, clips, brackets, partial frames or wet work will not be accepted.**
- All pieces under glass or plexiglass must be framed. However, unframed stretched canvases are acceptable if they have **finished sides** and **secure wiring**.
- 3D work may not be heavier than 150 lbs or taller than 108 inches. The piece must be stable in its position and securely attached to its base.
- Work containing open food products or biohazardous materials are prohibited.

ENTRY PROCESS AND FEES

This show is open to artists 18 years old and older who live within a 100-mile radius of State College, PA. Each artist may submit up to **two pieces** for consideration. However, **no more than one piece per artist** will be chosen for hanging.

The **entry form**, along with **digital images** of the work you are submitting and the **non-refundable entry fee** (payable to Art Alliance) are **due in the office of the Art Alliance by Wednesday, December 27, 2017**. Online payments or credit card payments by telephone are acceptable, but a signed entry form must be received by the deadline.

2D: One image per piece **3D:** Up to two images per piece
Please indicate the framed dimensions of your submitted work and label each image with your last name, first initial, and title of your piece. The quality of the images is important for the jurying process. **All images must be in JPEG format and must not exceed 2 megabytes.**

Deadline to enter: Wednesday, December 27
Fee: \$30 for members; \$40 for non-members

SALES AND CATALOGUE

Works may be for sale. Buyers interested in works will be put in contact with the Art Alliance. The Art Alliance will charge a 20% commission on the selling price of work sold. The Art Alliance will produce a catalogue of works and prices in exhibit.

SHOW DATES, HOURS AND RECEPTION

The Juried Show will run **Tuesday, February 27 through Friday, April 27, 2018**. The gallery is open Monday through Thursday, noon-6 pm and Friday, Saturday, and Sunday, noon- 4pm.

The reception will be held on **Thursday, April 26 from 5:30 to 7pm** at the Robeson Gallery in the HUB Robeson Center on the campus of Penn State. Award winners will be recognized at this time.

INSURANCE AND CONSENT TO REPRODUCE

All works will be insured for their value while in the care of the exhibit sites. **This exhibit requires that all artwork has a value placed on it for insurance purposes, even if it is not for sale.** Works will be insured by the HUB Robeson Galleries for the value indicated on the entry form. Each artist will be required to sign a contract for insurance purposes. These will be sent out by Penn State and should be sent back promptly.

JURYING

Jurying will be completed and a list of accepted works will be posted on the Art Alliance website, www.artalliancepa.org, by 4pm on Thursday, January 25.

DELIVER YOUR WORK

Artists whose work has been accepted for the exhibit must **deliver the work on Saturday, February 10 between 3-6pm or on Sunday, February 11 between noon-3pm**. Every artist must deliver work during these hours ONLY. All accepted work should be **delivered to the Art Alliance** at 818 Pike St., Lemont, PA. Make sure that your piece is ready for transport (with corners protected and fragile pieces wrapped) and that your name is clearly indicated on the wrapping.

Pick up your work at the Art Alliance on **Monday, April 30**.

ABOUT THE JUROR

B. Stephen Carpenter, II is Professor of Art Education and African American Studies; Co-Director of the Summer Institute on Contemporary Art (SICA); and, Chief Executive Artist for Reservoir Studio at Penn State. He is also a Founding Faculty member of the Summer residency MAT/MA in Art & Design Education at Vermont College of Fine Arts. For the 2017-2018 academic, Steve is Ida Ely Rubin Artist in Residence, MIT Center for Art, Science & Technology, and Artist and Learner in Residence, Easterly Parkway Elementary School. Steve is interested in curriculum theory, professional development through art for preK-12 educators, public pedagogy and participatory art practices, critical art education studios, and the global water crisis as curriculum. His mixed-media assemblages, installations, and performance artworks confront and disrupt social, historical, cultural, and political constructs. Steve has authored and co-authored book chapters and journal articles on art education, visual culture, and curriculum theory.
